Good Samaritan Hospital is located 30 miles north of New York City, in the southwest portion of Rockland County, New York, and just one mile from Bergen County, New Jersey.

### **From the Tappan Zee Bridge / Westchester County and points southeast**

- From the Tappan Zee Bridge continue north on Route 287/87 (New York State Thruway).
- Take Exit 14B and make a left at the end of the exit ramp onto Airmont Road.
- Go to the second traffic light and make a right onto Route 59 (Lafayette Avenue).
- Proceed approximately .8 mile to first traffic light and make a left onto Campbell Avenue.
- Take the 1st right where it says “Suffern Medical Pavilion – Medical Offices” & bear right.

### **From the Garden State Parkway North / New Jersey**

- Take the Garden State Parkway North.
- Proceed onto Route 287/87 (New York State Thruway) following signs to Albany.
- Take Exit 14B and make a left at the end of the exit ramp onto Airmont Road.
- Go to the second traffic light and make a right onto Route 59 (Lafayette Avenue).
- Proceed approximately .8 mile to first traffic light and make a left onto Campbell Avenue.
- Take the 1st right where it says “Suffern Medical Pavilion – Medical Offices” & bear right.
- We are on the 3rd floor.

### **From the Palisades Interstate Parkway North / Bergen County, lower Rockland & NYC**

- Take the Palisades Interstate Parkway North to Exit 9W (Albany – Route 287/87 – New York State Thruway).
- Proceed on the New York State Thruway to Exit 14B.

- At the traffic light make a left onto Airmont Road.
- Go to the second traffic light and make a right onto Route 59 (Lafayette Avenue).
- Proceed approximately 0.8 mile to first traffic light and make a left onto Campbell Avenue.
- Take the 1st right where it says “Suffern Medical Pavilion – Medical Offices” and bear right.

### **From Route 17 North / Bergen County and Orange County**

- Follow signs to New York State Thruway (287/87) southeast. Signs will indicate NYC.
- Proceed to Exit 14B and at the traffic light make a right onto Airmont Road.
- Go to the second traffic light and make a right onto Route 59 (Lafayette Avenue).
- Proceed approximately .8 mile to first traffic light and make a left onto Campbell Avenue.
- Take the 1st right where it says “Suffern Medical Pavilion – Medical Offices” and bear right.

### **From Route 4 / Bergen County**

- Take Route 17 North.
- Follow signs for Route 202-Suffern, just past Prestige Toyota and New York Sports Club.
- Continue bearing right and follow H signs, this becomes Washington Avenue.
- At the end is Sacred Heart Church. Make a right at the light.
- Continue for approximately one mile on Route 59. At the second traffic light make a right onto Campbell Avenue.
- Take the 1st right where it says “Suffern Medical Pavilion – Medical Offices” and bear right.
