can help you evaluate and manage possible toxic exposures, unusual clusters of symptoms, or frank environmental triggers of illness in your patients and their families.

Commonly encountered issues are contaminants in drinking water, outdoor settings, foods, indoor air and "sick" building syndrome. Some families also worry about unusual symptoms or potentially harmful exposures to lead, mercury, solvents, toxic plants, mold, pesticides, and household cleansers, that may cause clinical toxicity.

Your practice typically has very limited time to pursue and quantify environmental and social factors,¹ let alone track down inspection reports, regulations, and product safety data, and link it all to your patient's clinical presentation.² *That's where we can help!*

- Avoiding wasted lab tests and ineffective collection methods by specifying the appropriate specimens, analytes, and labs.
- Recommending specific interventions to mitigate exposure and adverse outcomes, based on the latest peer-reviewed evidence.
- Communicating with patients and their families about risks and remedial steps

Referral Process

Referrals can be made by telephone or through NextGen (BCHP providers). Most assessments begin promptly using telehealth visits, chart review and direct callbacks. Some cases may warrant in-person evaluation or virtual home visit. In many instances, precious time and money can be saved by selecting only the most relevant lab tests and ensuring the most reliable methods of collection and shipment of any needed specimens.
